

**TOWN OF NEW WHITELAND
ORDINANCE NO. 2015-11**

**AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR
THE COLLECTION, TRANSPORTATION, AND DISPOSAL OF SOLID WASTE AND
RECYCLING SERVICES THROUGHOUT THE TOWN OF NEW WHITELAND FOR
YEARS 2016, 2017, 2018 and 2019**

WHEREAS, the Town of New Whiteland, Indiana (Town), on behalf of its property owners and residents, contracts to provide for the collection, transportation, and disposal of solid waste and recycling services; and

WHEREAS, the Town, on or about the 1st day of September, 2015, entered into a contract with Republic Services of Indiana, LP (the "Contract"), for the collection, transportation, and disposal of solid waste and recycling services; and

WHEREAS, the Town is authorized to collect from its property owners and residents rates and charges to pay the Town's fees owed to Republic, pursuant to the Contract, and to recoup the Town's costs related to administering the Contract;

WHEREAS, the New Whiteland Town council, on November 17, 2015, at 5:00 p.m., held a public hearing on proposed rates and charges.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF NEW WHITELAND, INDIANA, AS FOLLOWS:

Defined Terms:

- **Dwelling**, for purposes of the Contract and this Ordinance, means a residential dwelling in the Town of New Whiteland, Indiana.

- **Year** for purposes of the Contract and this Ordinance, means a calendar year beginning on January 1, through the following December 31.

Section 1. Effective as January 1, 2016, the following Rates and Charges for the collection, transportation, and disposal of solid waste and recycling services, to be provided by the Town through its contract with Republic, are hereby approved and adopted.

Town's administrative charges	____.25/unit/month
Total	\$13.07/unit/month

<u>Description</u>	<u>Year 2019</u>
Collection charges per contract with Republic	\$13.21/unit/month
Town's administrative charges	____.25/unit/month
Total	\$13.46/unit/month

Section 2. Beginning on and after January 1, 2016, the Rates and Charges, as approved and adopted herein, shall be payable, each month, by the occupants and owners of each Dwelling.



Adopted on second and final reading, by the New Whiteland Town Council, on the 17th day of November, 2015.


